- 2. State frequency, intensity, duration, and onset (FIDO) of mental health symptoms

- 3. Document medical necessity of treatment in promoting continuity of care to support treatment planning
- 4. Construct ethical and lawful documentation when using the four (4) structural components of concurrent notes
- 5. State the importance of competence for accurate account of treatment, intervention, and care planning in clinical documentation
- 6. Apply assessment formulation as evident by vignette practices
- 7. State two (2) reasons patient centered documentation is effective in treatment planning.
