- New initiatives for 2026:
 - a. Clients who opt into the service will now receive text message reminders and updates about upcoming appointments and other messages.

Older Adults Administrator's Comments:

Nate Ramirez reported they have been talking about art and how they can submit art to participate in the Arts Festival in May. He added they have a vacant Peer Support Specialist position in Banning and they have a replacement in the background process and the hope is that person can also support the efforts to produce art on behalf of their program.
