

## **RIVERSIDE COUNTY BEHAVIORAL HEALTH COMMISSION**

MEETING MINUTES FOR November 5, 2025 • 12:00 pm to 2:00 pm

### **CALL TO ORDER, PLEDGE OF ALLEGIANCE, ROLL CALL AND INTRODUCTIONS –**

Madam Chair Brenda Scott called the Behavioral Health Commission (BHC) meeting to order at 12:02 pm and led the pledge of allegiance. Commissioner attendance was taken by roll call and followed by introductions.

### **MINUTES OF THE PREVIOUS MEETING –**

Victoria St. Johns made a motion to approve minutes as written from September 3, 2025 and Rick Gentillalli seconded the motion, and all were in favor.

**CHAIRPERSON'S REMARKS –** Madam Chair Brenda Scott said she missed seeing everyone in our BHC meeting last month as it had to be unexpectedly cancelled due to unforeseen circumstances and encouraged all to get involved with the BHSA planning process and announced upcoming NAMI walks.

### **COMMISSION MEMBER REMARKS –**

Launa Wilson requested that the letter sent to the commission from Board of Supervisor Karen Spiegel's office be placed into the minutes for public record.

Beatriz Gonzalez echoed the sentiments of Launa Wilson.

Rick Gentillalli shared that the letter received from Supervisor Spiegel's office he understood it to be from her office and not the entire BOS and felt it was sent to the commission as a courtesy letter in efforts to help the commission run smoother.

Elysse Rico shared that the letter was meant as a reminder to the commission of their roles and responsibilities.

April Smith announced that Supervisor Gutierrez district will be handing out free produce to the community on 11/8/25 and 11/24/25 in Moreno Valley.

### **PUBLIC REMARKS –**

Ms. Johnson announced she would reach out to county counsel regarding the letter being requested to be shared in the minutes for public record.

Melissa Vasquez shared the Western Eagle Foundation in Temecula is having their free food Friday that feeds a family of four from 10am to 1pm every other Friday through the month of December and would share the information with the BHC liaison to be sent out via email.

### **DIRECTOR'S REPORT – Dr. Matthew Chang**

Dr. Chang provided a brief update and announced all projects are on target to open as scheduled if not sooner and shared there would be 58 beds for continuum of care. Dr. Chang also thanked the commission for their continued support and dedication to the hard work, time and effort they put into Behavioral Health and SAPT to provide the best care possible to the community we serve.

## **CELEBRATE RECOVERY- Family Advocate (Will Wynn)**

Willard Wynn, Family Advocate Program Manager, introduced Maria Rodrigues (Angie). Ms. Rodrigues shared that her brother received services from the department, but it did not go without challenges. Prior to receiving services, he had been arrested so she sought out services through Main Street Clinic and met with Maria Algarin who provided her with support and got her engaged with family to family and other support groups where she was able to build connections with other family members. Ms. Rodrigues was able to later support her brother by getting him on conservatorship, linking him to outpatient services where he was able to start medications. This encouraged her to work with families in similar situations, and she became a family advocate with RUHS BH. She continued to advocate on her brother's behalf many times as the medication needed to be adjusted and other services were needed. Ms. Rodrigues shared that her brother was placed at Sylmar and went missing from there for about a year and a half after leaving the facility and was last hospitalized in 2016. She shared that he has now been living in San Jacinto for 13 years, however, he did leave the facility last year and was missing for 10 weeks but was located in Corona and started on his medications again and has been doing well since. She concluded that she is retiring with the department but has been grateful for the experience to help her brother and other families.

Greg Damewood announced the Criminal Justice committee will be meeting on 14<sup>th</sup> Street and all are welcome to attend in person and Western Regional Advisory Board will be meeting today at 3pm virtually and encouraged all to attend.

Brenda Scott requested Ad-Hoc committees established for forms and bylaws.
