

RIVERSIDE COUNTY BEHAVIORAL HEALTH COMMISSION

MEETING MINUTES FOR July 2, 2025 • 12:00 pm to 2:00 pm

CALL TO ORDER, PLEDGE OF ALLEGIANCE, ROLL CALL AND INTRODUCTIONS -

Madame Chair Brenda Scott called the Behavioral Health Commission (BHC) meeting to order at 12:01 pm and led the pledge of allegiance. Commissioner attendance was taken by roll call and followed by introductions.

MINUTES OF THE PREVIOUS MEETING -

Victoria St. Johns made a motion to approve minutes as written from June 4, 2025 and Greg Damewood seconded the motion, and all were in favor.

CHAIRPERSON'S REMARKS – Madam Chair Brenda Scott reminded the commissioners to consider a site visit for the future and also announced the senate passed a current legislation that will include a lot of cuts in Mental Health and encouraged others to send letters to their congressman.

COMMISSION MEMBER REMARKS -

Greg Damewood agreed with Madam Chairs remarks and announced he has written numerous letters and recently received a memo from the department of developmental services that mentioned they will instruct all regional centers to help support individuals and attempt to address mental health.

PUBLIC REMARKS – Joe Banios with Treatment Atlas returned to give thanks and shared his appreciation to the department of Behavioral Health and announced that this year they had half a million visitors and on target to exceed that this year. In closing, he gave thanks to Heidi and her team for their partnership and stated he looks forward to their continued work together.

DIRECTOR'S REPORT – Dr. Matthew Chang TABLED

CELEBRATE RECOVERY- Parent Support (Maria Arnold)

LaGwenda Hill, Senior Certified Peer Support Specialist, introduced Deidre Devor on behalf of Maria Arnold, Parent Partner Program Manager. Ms. Devor shared her recovery journey and began by sharing she was an addict for fifteen years, homeless for five years and a domestic violence survivor. She had lost her rights over her children and went to MFI and completed inpatient treatment as well as graduated from family preservation court earlier this year. She also attended the Moms program and received services and through them they were able to assist her with accessing WIC services so that she no longer had to pay full cost for formula and would not have to continue donating blood to afford the formula. During family preservation court she agreed to a urine test two to three times a week, as well as attending three NA classes, Domestic Violence and parenting classes as well as Triple P parenting classes. Through the classes she completed she learned how to stop parenting out of guilt and rebuild her relationships with her children. She announced that today she is 448 days sober and sponsoring another parent and being an example that Moms do recover. She has regained rights over some of her children and continues to work on taking care of all four of her children and looking forward to her future with her children.

1. Mental Health Services Act (MHSA) Update - (David Schoelen)

a. Approve MHSA Annual Update (Action Item)

David Schoelen, Mental Health Service Act Administrator, provided an update on the 2025/2026 MHSA Plan (please see link to power point presentation below). Mr. Schoelen then asked for the commission's approval to the MHSA plan which he provided to them for review in advance. Commissioner Greg Damewood made motion for approval, Commissioner Victoria St. Johns seconded the approval, all were in favor with one abstention from Commissioner Beatriz Gonzalez.

2. Substance Abuse Prevention and Treatment Program (SAPT) Update – (April Frey)

Heidi Gomez, SAPT Administrator, announced there will be no 1 Life 1 Heart 5k Walk in 2026 but this year there were three held in Murrieta, Riverside and the Desert. Combined there were over 200 exhibitors, 150 volunteers, and it was an overall well received event. She also shared that this year there were 139 less deaths reported from overdose poisoning. Ms. Gomez also shared the Recovery Happens event will take place on September 25, 2025 at Fairmount Park in Riverside and encouraged everyone to attend and invite others.

3. Care Court Update – (Marcus Cannon)
