- Riverside New Life (RNL) Rollout Day Treatment Intensive (DTI) & Day Rehabilitation (DR)

Day Treatment Intensive: CCR Title 9, § [1810.213](#)

Day Treatment Intensive is a structured, multi-disciplinary program of therapy that may be an alternative to hospitalization, avoids placement in a more restrictive setting, or maintains the individual in a community setting where services to a distinct group of individuals is provided. Services are available **for at least three hours** and less than 24 hours each day the program is open. Service activities may include but are not limited to:

- Assessment
- Plan Development
- Therapy
- Rehabilitation

Day Rehabilitation: CCR Title 9, § [1810.212](#)

Day Rehabilitation is a structured program of rehabilitation and therapy to improve, maintain, or restore personal independence and functioning consistent with requirements for learning and development, which provides services to a distinct group of individuals. Services are available **for at least three hours** and less than 24 hours each day the program is open.

- Assessment
- Plan Development
- Therapy
- Rehabilitation
