**CALL TO ORDER, WELCOME AND SELF INTRODUCTIONS:**

Mark Miller called the meeting of the Riverside County Desert Behavioral Health Board to order at 12:05 PM. Self-introductions of all who were in attendance in person or by teleconference followed.

**CORRESPONDENCE AND ANNOUNCEMENTS:**

Shawn Harris said the Children's Program at the Myers site had their first art show which featured 158 entries and 64 pieces were sold for a total of \$436.00.

**ACCEPTANCE OF MINUTES:**

Mark Miller asked if there were any additions, corrections, or deletions to the board minutes of the October 14, 2025 meeting. There were no additions, corrections or deletions that needed to be made. Tori St Johns made a motion to accept the minutes, Jim Jones seconded the motion, and it passed by a unanimous vote.

**NEW BUSINESS:**

**417 Recovery:**

Honor Moore, the Director of Community Outreach at 417 Recovery, gave a presentation utilizing some PowerPoint slides. She said it is a comprehensive, clinically based treatment for adolescents aged 12-17. 417 Recovery is an adolescent Partial Hospitalization Program (PHP) and Intensive Outpatient Program (IOP) specialized care for clients struggling with mental health, substance use disorders (SUD), or behavioral issues. The program serves families in Palm Desert, Murrieta, and Mission Viejo, CA.

Richard Divine said he would be unable to continue his role as Chairperson of the Board and based upon the feedback received, the committee recommended Tori St Johns as the new Chairperson, Dr. Janice Quinn as the Vice-Chairperson and Mark Miller as the Secretary. Dr. Quinn opened the floor to any prospective new nominees and none were received. Tori St Johns, Dr. Quinn and Mark Miller left the room while the final vote was tabulated. In the end, Tori St Johns was elected as the new Chairperson for 2026, Dr. Quinn the Vice-Chairperson, and Mark Miller the Secretary. Congratulations were given to the new Board for 2026.

**2026 Standing Committees Desert Board Representative Positions Open for Change or Renewal:**

Joe Butts said he was willing to take over the Desert Representative for the Veterans Committee. Eva Guenther-James said she is currently unable to fulfill her role as the Criminal Justice Committee liaison due to scheduling conflicts with other activities she is participating in. Joe Butts offered to take on responsibility for this also. Tori will assume responsibility for the Main Behavioral Health Commission Report as the new Chairperson. Joe Butts was removed as co-representative of the Adults Committee given his new assignments. Eva Guenther-James will take over the Housing Committee representative.

**Transitional Age Youth (TAY) Program Update:**

Rob Bohon-Lara reported on activities at the TAY Center. For more information, refer to the attached calendar of events.

**CHILDRENS SERVICES MANAGER COMMENTS:**

Rachel Gileno covered this for Kelly Grotsky. Rachel said TAY Desert Flow was awarded a \$453,433 2-year grant to provide Housing Navigation Services and Support for youth ages 18-24 who are experiencing homelessness. She said any youth between 18-24, who meets the definition for homelessness, can qualify. She added that priority will be given to youth in the Coachella Valley and the goal is to serve 80 youth per year. Youth do not have to be linked to Behavioral Health services or a Behavioral Health program. Rachel said they are in the process of hiring a housing navigator. She said this will be a Peer Support Specialist position and the ideal candidate will have lived experience of previous challenges with housing/homelessness. There have been discussions about utilizing the services of this position at Harmony Haven also. Rachel said ECM Team will be up and running very soon.

**ADULT SERVICES ADMINISTRATOR'S COMMENTS:**

Rachel Gileno reported a new full-time Clinical Therapist (CT) started in Blythe. She also reported the Whole Person Health Score rollout was completed in the desert area. This new tool is now being utilized with all new members who establish care in the desert clinics and will assist with identifying social determinants of health and improving engagement in and connection to the resources needed to address the whole person.

Rachel said desert region RivCoOne initiatives this year included Strengthening Blythe Communities, which was a series of Rapid Improvement Events (RIE) to address the community's concerns with linkage and access to care. Based on the success of this endeavor a new series of Rapid Improvement Events has been scheduled to occur in the Banning area. It will be titled the Pass Community Model and encompasses Whitewater to Calimesa. This area has one of the lowest Healthy Places Index scores in Riverside County. The first RIE was held in Banning last month and the next series of RIE will be held next year to address disparities and increase linkage and access to care.

Rachel said she is in the process of hiring a new Oasis Case Management Supervisor and that person will be starting in December.

**Older Adults Administrator's Comments:**

Nate Ramirez reported Tony Ortega's office assistant retired last month and he is in the process of hiring a new one.
