## Riverside University Health System-Public Health Welcomes the City of Corona to Blue Zones Activate Riverside County Well-Being Initiative

The City of Corona is the sixth Riverside County community to participate in Blue Zones Activate, a health and well-being assessment to create a plan to help residents live better and longer.

Riverside University Health System-Public Health (RUHS-PH) welcomes the City of Corona to the effort. The readiness and feasibility assessment is the first step for Blue Zones to come together with the communities and determine how to make them healthier places to live, work, grow up, and grow older.

"The City of Corona is working hard to improve the quality of life for our residents" said Corona Mayor Tony Daddario. "Blue Zones fits nicely with the other active and healthy living efforts we are currently undertaking like the <a href="Parks and Recreation Master Plan">Parks and Recreation Master Plan</a>, the <a href="City Park">City Park</a> <a href="Master Plan">Master Plan</a>, the <a href="Downtown Revitalization Plan">Downtown Revitalization Plan</a>, and the <a href="Trails Master Plan">Trails Master Plan</a>. The Blue Zones Activate Assessment will help us see across a range of issues to help align our efforts with other community partners to make Corona better."

The Blue Zones team have been working with Riverside County leaders, organizations, and residents to learn more about the strengths, needs, and challenges that residents are facing today. The work surveys countywide policy with a detailed focus on the cities of Banning, Coachella, Riverside, Corona, and the unincorporated communities of French Valley and Mead Valley.

"We are happy to hear that the City of Corona is taking part in the Blues Zones health and well-being assessment. This demonstrates a sincere commitment to residents' health, and we are excited to support this process," said Dr. Shunling Tsang, Riverside County deputy public health officer.

After the assessment period, Blue Zones will create a transformation plan that, once implemented, can drive widespread improvements in well-being, reductions in healthcare costs, and improve economic vitality in the region.
