### RODA received OD2A: LOCAL Funding!

RODA is proud to announce that we've been awarded one of @CDC's Overdose Data to Action grants! This grant will help us reduce overdose deaths and related harms. The 5-year funding will continue to boost RODA's prevention activities, help us gather and analyze more data, and strengthen community partnerships to save more lives, faster!

#### **CDC Grant Submission Feedback:**

Overall, this is an excellent, very well thought out proposal with few weaknesses. There is strong organizational capacity, and they are well-versed in working with disproportionately affected marginalized populations such has Hispanic/Latinx populations. They have an impressive number of working relationships with committed partners. Finally, they are wellexperienced in utilizing overdose related data from diverse sources for data to action projects.

### August 31 is <u>International Overdose Awareness</u> <u>Day</u> (IOAD)!

IOAD is the world's largest annual campaign to end overdose, remember without stigma those who have died from overdose, and acknowledge the grief of the family and friends left behind. The IOAD 2023 theme "Recognizing those people who go unseen" is about acknowledging people in our communities who are affected by overdose but might go unseen in the crisis. # Grant Cycle Wrap Up

- Over 5700 Community members, county staff, and students have been trained.

- 49,300 Safe use supplies and kits have been distributed.
- 10,000 meals have been provided.
- 160 Leave Behind Naloxone kits have been left provided after an overdose or suspected overdose by EMS since the program's inception in March 2022!
- 1,100 reported overdose reversals!

Case management services provided by Public Health Nursing - participating partners refer eligible clients to the Public Health Nurse (PHN) for case management. The PHN assesses and works closely with case-managed clients to connect them with the services they need.



EMS Naloxone Leave Behind Program -Implemented by Riverside Emergency Medical Services Agency (EMS), EMS provides individuals and/or families of individuals who experienced an overdose with Naloxone, education on how to recognize and respond to an overdose using Naloxone, and harm reduction resources.

The DHCD in partnership with RUHS-PH has created an action plan to address the high rate of overdose deaths plaguing the community of Indio California utilizing a harm reduction education framework that leveraged existing county partners. ABC Recovery Center of Indio was selected as the provider of these education awareness sessions.



Inland Empire Health Plan (IEHP) - Clinical Pharmacy Programs will use academic detailing while leveraging other techniques, including harm reduction, to increase the use of non-opioid medications, decrease high-risk opioid prescribing.



Healthy Families America is an Evidence-based Home Visitation Program for families who are at risk for child abuse & neglect, and other poor childhood outcomes

Home Visits Occur: Weekly/bimonthly for at least 3 years and up to 5 years as needed

Riverside County Sheriff's Department Chris Mason-Certified Crime and Intelligence Analyst – thank you for your partnership and for providing your weekly, comprehensive Situational Awareness Reports!







(OAPP) – Implementation of a youth-based curriculum, risk-screening, and referral process for overdose prevention in middle and high schools in Riverside County. At-risk students are referred to Behavioral Health Specialists or counselors on campus.
